

# Cotton Ranch Metropolitan District

## Sky Legend Notice

This notice is to advise Sky Legend property owners that the raw water irrigation system will be turned on by May 1, 2022.

The following maximum area of sod and water usage tiers have been established and will be strictly enforced for each home type as follows:

	<u>Cottage</u>	<u>Traditional</u>	<u>Custom</u>
Maximum Square feet of Sod	900	1,200	1,500
Base Fee (Fee covers common areas irrigation too)	\$41	\$41	\$41
Base Fee Covers Base Gallons per month (Tier 1) up to	4,800	6,000	7,500
Tier 2 Fee per Gallon	\$0.01	\$0.01	\$0.01
Tier 2 Fee for Gallons Over Tier 1 up to	6,400	8,000	10,000
Fee per Gallon for all usage over Tier 2	\$0.03	\$0.03	\$0.03

The primary way you can control your water usage is by limiting the duration of your watering times. As an additional water conservation procedure, no irrigation watering is allowed between the hours of 11:00 a.m. and 3:00 p.m. and no watering is allowed on Mondays. The golf course usually waters between 8:00 p.m. – 3:00 a.m. so homeowners should also refrain from irrigating during those times. The ideal time for you to water is between 6:00 a.m. – 8:00 a.m. and no more than three times a week. Shawn Gerber is operating the irrigation system for Sky Legend's common areas again this year.

To accommodate these procedures, irrigation meters will be read and billing statements will be sent out monthly. To avoid any surprises for excessive water usage as these new procedures are implemented, we recommend that you check your own meter weekly during May to ensure you will not exceed the base usage as shown in the table above.

It is the responsibility of each homeowner to inspect your irrigation system to ensure your system is operating properly. Please make sure the water meter box is clean and accessible for meter readers. The District has discovered several individual meters have failed and are not recording water usage. The District has purchased replacements meters in bulk and selling them to property owners at a discounted cost of \$140. Please contact Chris Meister at (970) 390-6131 to purchase a new meter to be installed by your irrigation contractor. The District will need to inspect the meter after installation.

The District plans to identify and notify each property owner with a faulty meter and will require those meters to be replaced by May 31, 2022. Property owners who fail to comply will be billed \$200 per month for the broken meter.

As a reminder the Gypsum Creek Golf Course is for golf related activities only. For your protection, please refrain from being on the golf course.
